AGES 6mos - 3yrs: PARENT'S DAY OUT (PDO)

Parents of PDO aged children may choose to have their child attend school 1 day through 5 days per week in any combination so long as the weekly schedule remains consistent & classroom space is available to do so.

** Registration for the 2024 - 2025 school year begins on February 5th for new families. If enrolling two or more children for the school year, the total registration fee for the school year is \$300.*

Once we accept your child enrollment submission through [ChildPilot](#)*, our registration & communication platform, you:

- Agree to abide by the rules & procedures of Claire's Day School as outlined in our [parent handbook](#), and
- Acknowledge your understanding of the PDO tuition policies below & will remit all applicable outlined fees:
 - You understand that your child's space for PDO is secured with payment of the registration fee and first month's tuition, and these fees are non-refundable and non-transferrable regardless of circumstance.
 - You understand that the tuition fees outlined above for the 2024 - 2025 school year are the same rate each month from September through May, regardless of the number of school days in any given month, and acknowledge the [school year calendar and holiday schedule](#).
 - You understand that if reducing days or dis-enrolling from the program, you must provide one month's notice, and that tuition will not be altered until that month long period has passed. For example, if your child is enrolled for three days per week, and you notify the school in October that you would like to reduce your child's days to only two days per week, you will still be billed for the 3-day rate in November before the 2-day rate takes effect starting in December. You may add days to your child's schedule at any time should there be availability to do so.
 - You understand that tuition must be paid each month from your child's start date through the end of the school year term, unless providing notice to vacate as outlined above, and that failure to pay any month of tuition will forfeit your child's space without refund of the registration fee.
 - You understand that while Claire's Day School allows you to *try* to make-up a day your child may have missed, make-up days are *not guaranteed* because of state licensed permitted ratios. Make-up days, if offered, are a privilege rather than an entitlement, & the only day your child is guaranteed to attend is the day or days he or she is enrolled. Scheduled holidays outlined on the [school year calendar](#), as well as a weather-related closing (typically because of icy roads) are not allowable make-up days.
 - For families who wish to reserve a school year space in advance for an infant who will not yet have turned 6mos by the time the school year begins, you understand that permission to do so *may* be granted at our discretion, and that additional non-refundable & non-transferrable months of tuition must be prepaid in order to secure the space, which will be determined on a case by case basis:
 - As a common example, a family with an infant beginning in January would be required to pay the entire spring semester (January through May) in advance, as even though your child would not be attending during the fall semester, we would still be holding the spaces during that time to ensure availability for your child's January start, and thus unable to collect tuition from September through December with those spaces held for your child's future start.

** Enrichment is a certified teacher lead program offered to kindergarten bound students in lieu of stay & play to help build stamina & increase attention span. You may read more about enrichment class [here](#).

- Agree to abide by the rules & procedures of Claire's Day School as outlined in our [parent handbook](#), and
- Acknowledge your understanding of the preschool tuition policies below & will remit all applicable outlined fees:
 - You understand that your child's space for Preschool for the 2024 - 2025 school year is secured with payment of the registration fee and first month's tuition for the morning preschool program, and that these fees are non-refundable and non-transferrable regardless of circumstance.
 - You understand that the tuition fees outlined above for the 2024 - 2025 school year are the same rate each month from September through May, regardless of the number of school days in any given month and acknowledge the [school year calendar and holiday schedule](#).
 - You understand that you must provide one month's notice if dis-enrolling your child from our preschool program, and that tuition will not be altered until that month long period has passed.
 - For example, if you give notice of disenrollment in October, you will be billed for November's tuition before billing ceases in December. The registration fee is not refundable.
 - You understand that tuition must be paid each month from your child's start date through the end of the school year term, unless providing notice to vacate as outlined above, and that failure to pay any month of tuition will forfeit your child's space.
 - You understand that morning preschool does not allow for make-up days due the way the curriculum is structured, as well as the need for the teacher to have students follow a consistent class program schedule. Your child may be allowed to make-up a missed afternoon with teacher permission on an afternoon he or she does not usually attend, but this is not guaranteed.
