

# Summer 2024 Tuition & Policies (Ages 6mos - 5yrs)



Thank you so much for considering Claire's Day School for your child's summer care and early education!

Your child's space is secured once we receive the fees outlined below for the program you are selecting, as well as your submission of the electronic enrollment form through ChildPilot, our online registration & communication platform. Please submit a [registration inquiry](#) which will seamlessly integrate with ChildPilot. Once submitted, kindly [email us](#) to receive a personalized link to create your ChildPilot account & fill out the required registration forms.

By submitting your child's enrollment record through [ChildPilot](#), you acknowledge with your electronic signature that you understand the fees, terms, & conditions outlined in this document of our program for which you are enrolling your child.

We do not collect any fees unless your child receives a place in the program; however, once you choose to reserve this space for your child, **all summer tuition fees are owed regardless of attendance and are non-refundable.**

Why is this? Classes have a limited number of spaces. Once a class fills, we begin to wait list families. Often, by the time a space becomes available upon a student dis-enrolling, those students on the waitlist have made other arrangements, and that spot may go unfilled. Because our costs for staffing, housing, utilities, etc. remain the same regardless of the number of students, we must ensure classes are filled to the best of our ability. For this reason, please ensure you are certain of program you are selecting. If space permits, you might have the option of switching to different summer days, but there is no guarantee of this.

## SUMMER 2024 TUITION & INFORMATION

- Summer class hours are 9:00a - 3:00p. You may pick-up your child earlier if you wish, but there is no discount for doing so.
- Earlier (8:30) drop-off and later (3:30) pick-up are also available for additional fees outlined below.
- Summer 2024 programs begin Tuesday, May 28<sup>th</sup> & operate through Thursday, August 1<sup>st</sup>, with a break (no school) July 1<sup>st</sup> - 4<sup>th</sup>. We are closed Fridays during our summer session.
- The tuition prices listed below are for the whole summer term (not monthly). All tuition must be paid at the time of registration\*. For students only attending during the summer and not the school year, there is a summer only registration fee of \$100. If your child was enrolled for the 2023 - 2024 school year, or is enrolled for the upcoming 2024 - 2025 school year, there is no additional summer registration fee.

Once enrolled & classroom space is allocated for your child, you acknowledge and agree to the following summer term policies:

- Your child's space for the summer 2024 program is only secured with full payment of the tuition fees outlined above, and that these tuition fees are non-refundable and non-transferrable regardless of circumstance.
- \*You *may*, at our discretion, be given the option to make monthly payments towards summer tuition. If granted, then:
  - The percentage of the balance owed each month would correlate with the number of remaining months until summer term begins. For example,
    - A family enrolling in February would pay a quarter of the summer tuition balance each month from February through May.
    - A family enrolling in April would pay half of the owed fees in April, & the other half in May.
  - Payment of the registration fee alone does not hold space in our summer school program. A significant portion of the balance must be remitted at the time of enrollment.
  - Balances not paid in full by the start of summer term will result in the forfeit of your child's space, & no refund of partial tuition payments will be provided.
  - As said above, the balance of summer tuition is owed regardless of your child's attendance, & legal action may be taken should breach of contract occur.
- You understand that this summer's school session runs from Tuesday, May 28<sup>th</sup> through Thursday, August 1<sup>st</sup>, with no school July 1<sup>st</sup> - 4<sup>th</sup>, & that the summer tuition listed above does not change regardless of days or weeks missed. In addition, you understand there is no option to enroll for only certain weeks of the summer term. In other words, our summer school session is "all or nothing."
- You understand that while Claire's Day School may try to allow for make-up days that your child may have missed, summer make-up days are not guaranteed because of state licensed permitted ratios, and that your child is only guaranteed to attend on the days you have selected. You also understand that if your child is of enrichment class age (3.5-6yrs), make-up days are at the sole discretion of the classroom teacher, as planning and curriculum may not allow for additional children. *Potential make-up days are a privilege, not a right.*
- You understand that the July 1<sup>st</sup>- 4<sup>th</sup> scheduled holiday closings are not allowable make-up days.
